## 14 **Session 1: Welcome**

15 The Global Sustainability Standards Board (GSSB) Chair Judy Kuszewski (henceforth the Chair)  
16 welcomed the GSSB and presented an overview of the meeting agenda. The GSSB was presented  
17 with the following items for approval:

## 23 **Session 2: Key conclusions of the** 24 **draft Sector Standard for Coal**

25 Noora Puro, Manager Sector Program, presented the progress of the Sector Standard project for  
26 coal since the exposure draft was released for public comment. The following points provide an  
27 overview of public comments received that led to significant changes in the draft Standard:

- 28 • The list of likely material topics did not change due to the public comments received.
- 29 • Most of the feedback was related to climate-related topics, followed by comments on topics  
30 related to environmental management.
- 31 • Key changes to the draft Standard targeted the following topics: Topic 12.2 Climate  
32 adaptation, resilience, and transition; Topic 12.3 Closure and rehabilitation; Topic 12.4 Air

33 emissions; Topic 12.13 Asset integrity and critical incident management; Topic 12.20 Anti-  
34 corruption.

- 35 • Major revisions were also made in the section describing the sustainability context for the coal  
36 sector. The section is titled: The sector and sustainable development.
- The International Council on Mining and Metals has been consulted on a number of topics  
where an overlap is anticipated with the mining Standard to future proof the coal Standard.

37 The presentation concluded with questions and concerns from the GSSB regarding proposed  
38 changes to the draft coal Standard. Questions asked by GSSB members and corresponding answers  
39 from the SD are as follows:

- 40 • **GSSB:** What is the weight on transition in the coal Standard compared to the weight in  
41 transition in the oil and gas Standard? Do we have the balance right in terms of weight  
42 proportional to response?  
43 **SD:** The message from the WG is that coal should be treated differently from oil and gas; coal  
44 is the priority in the low-carbon transition. Governments and investors are targeting coal to be  
45 phased out, as seen in COP26 messaging. Stakeholders and WG members have indicated  
46 the urgency to transition away from coal, but it is important to recognize the impacts that  
47 existing operations have and will continue to have on communities. Plus, the need to  
48 transition and the impacts of those transitions. Therefore, there is a slight increase in  
49 reporting related to transition.
- 50 • **GSSB:** Were there any public comments regarding the sector's scope in terms of what should  
51 be reported under transportation?  
52 **SD:** We did not receive any direct comments on this, but it has been a discussion point  
53 outside of public comment. The scope of this particular Standard would include transportation  
54 which will be the same proposal for mining; it is about the transportation of the mineral.  
55 General transport, for example, food, supplies, and workers would be best covered by a  
56 separate transport Standard.

## 57 **Session 3: Approval of the proposed** 58 **working group of the GRI Sector** 59 **Standard Project for Mining**

60 Senior Coordinator, Veronica Wachong, presented to the GSSB the composition of the proposed WG  
61 of the GRI Sector Standard project for mining:

- 62 • 89 applications were received, and 38 applicants were interviewed; the proposed WG  
63 includes 20 members: 18 of those applicants interviewed and 2 nominations from the Council  
64 of Global Unions representing labor.

- 65 • The WG composition includes representatives from Africa, Asia, Europe, North America,  
66 Oceania, and South America, large-cap and small/mid-cap representation, a range of  
67 commodities, and relevant associations.
- 68 • Despite the balance achieved in the proposed WG composition, some limitations need to be  
69 addressed through additional stakeholder engagement during the development of the  
70 Standard to ensure sufficient coverage of, e.g., less represented geographical contexts, non-  
71 metallic mining, quarrying, artisanal and small-scale mining.

72 The GSSB resolved to approve the SD's proposed WG for the mining sector. The GSSB further  
73 expresses gratitude to everyone who volunteered to be part of the project.

## 74 **Session 4: GRI Topic Standard**

### 75 **Project for Biodiversity**

76 Elodie Chêne, Manager Standards, presented the GSSB with the project update:

- 77 • GRI has published two press releases relating to the biodiversity project. The first  
78 communication announced the alignment of the standard development process with the  
79 EFRAG Task Force, and the other was an announcement of the collaboration with CDP and  
80 TNFD.
- 81 • GRI has joined EFRAG's biodiversity cluster meetings and provided feedback on the  
82 Standard proposal.
- 83 • GRI has also invited EFRAG to join initial conversations with TC members to inform each  
84 other throughout the process.
- 85 • As CDP is represented in the TC, the collaboration will aim to harmonize approaches to  
86 disclosures on biodiversity.
- 87 • GRI will be part of the TNFD process through their forum and as a knowledge partner. There  
88 is an expectation that the revised GRI Standard would provide input on the risk management  
89 and disclosure framework. Completion is earmarked for the end of 2023.
- 90 • The project has commenced with an initial scoping survey and interviews with TC members  
91 to identify the main work areas for revising the Standard.
- 92 • An exposure draft is to be made ready for public comment in the May-June period.

## 93 **Session 5: GSSB work program and**

### 94 **meeting schedule**

95 The Chief of Standards, Bastian Buck presented, the following points for consideration:

- GSSB members were invited to provide feedback to develop the proposal for the addendum to the GSSB work program. Gustavo Sinner has provided input.

- The aim is to have a proposal of the GSSB work program ready for approval in January or February, depending on developments in the weeks to follow.
