## Session 1: Welcome to meeting

- 10 The Global Sustainability Standards Board (GSSB) Chair Carol Adams (henceforth the Chair)
- 11 welcomed the GSSB. The Chair presented an overview of the meeting agenda. A quorum was
- established, and the above items were presented to the GSSB for approval.
- 13 The Chair enquired about the process used to track GSSB comments on exposure drafts. Chief of
- 14 Standards Bastian Buck explained the process as follows:
  - If GSSB comments are made on exposure drafts, the Standards Division (SD) will agree as part of the approval, which of these comments (if any) are to be implemented before public consultation.
  - GSSB comments not implemented before public consultation will be brought to the attention
    of the respective working group / technical committee (TC) for consideration.
  - At the end of a project, the SD will review all GSSB comments received and provide an overview to the GSSB on how comments have been addressed before the final approval.
- 22 The action point list was briefly discussed and clarified. There are no updates or additions to the list.

# **Session 2: Topic Standards Project**

- 25 Director Standards, Harold Pauwels, and Manager Standards, Izzy Ensor presented the GRI Topic
- 26 Standard Project for Labor, phase 2, for approval. An overview of the exposure drafts for Training and

- Education, and Working Parents and Caregivers was provided. This was followed by a presentation of the comments received from GSSB members on the exposure drafts.
- 29 The following are SD responses to additional GSSB questions:
  - The TC highlighted the importance of financial investments and training hours, which the
    guidance addresses through optional reporting. Disclosure is not mandatory, but
    organizations can show their investments in this aspect if they wish.
  - New terms can be defined in the guidance using authoritative instruments. Terms used across Standards can be included in the glossary as part of the revision process.
  - The revision of the current non-discrimination Standard, which is being developed in collaboration with the TC and advisory group (AG), will look at all parts of the employment relationship. The TC and the AG will consider all forms of discrimination in the coming meetings.
