GRI Topic Standards are issued by the Global Sustainability Standards Board (GSSB), GRI's independent standard-setting body. The GSSB oversees the development of the GRI Standards according to a formally defined <a href="Due Process Protocol">Due Process Protocol</a>. In its Work Program 2023-2025, the GSSB has identified the topic of pollution as a priority for developing disclosures for (a) Topic Standard(s).

The pollution-related disclosures will be developed within the Topic Standards Project for Pollution. The disclosures will allow organizations to disclosure their impacts in relation to pollution. The purpose of the GRI Pollution Working Group is to contribute expertise to the development of a Topic Standard(s) for the topic of pollution for the consideration of the GSSB.
