9 Session 1: Welcome to meeting

- 10 The Global Sustainability Standards Board (GSSB) Chair Carol Adams (henceforth the Chair)
- 11 welcomed the GSSB. The Chair presented an overview of the meeting agenda. A quorum was
- established, and the above items were presented to the GSSB for approval.

GRI Sector Standard Project for Textiles & Apparel – Exposure draft

- 15 Director Sector Standards, Gelkha Buitrago, and Senior Manager Standards, Peter Dawkins,
- 16 presented the GRI Sector Standard Project for Textiles and Apparel Exposure Draft for approval. An
- 17 overview of the feedback from GSSB members was provided. This was followed by a presentation of
- 18 the comments received from GSSB members on the exposure draft, including clarification on
- 19 questions and suggested changes. The project team answered all questions and comments via
- 20 Filestage, including how the suggested changes are being implemented. It was explained that some
- 21 changes will be implemented prior to public consultation, while some specific comments will be further
- 22 considered together with the input of the public consultation. There was no further discussion or
- comments from the GSSB, and it was agreed to move forward with the approval of the exposure draft.
- 24 After a slight delay to achieve quorum among the GSSB, quorum was achieved.

Quarterly Update Implementation Project Schedule 2025

- 28 Chief of Standards, Bastian Buck, opened up discussion with GSSB members on the latest updates
- 29 with the Work Program. The GSSB was provided with a newly implemented quarterly update on all
- 30 projects and commitments prior to the meeting. Feedback was sought from the GSSB on the
- 31 suitability of the new format and whether there were any questions on the project updates or areas for
- 32 improvement. The GSSB was invited to provide any feedback post-meeting, and if all is satisfactory,
- 33 this will be the format and manner of update going forward. The GSSB indicated their satisfaction with
- the new format, and no further discussion took place.

Final Project Proposal – Impacts, Risks and Opportunities (IRO)

- 37 Chief of Standards, Bastian Buck, presented an update on the project proposal before final approval.
- 38 While initial backing and collaboration have been secured from the Sustainability Standards Board of
- 39 Japan and TNFD, further partnerships in other jurisdictions are encouraged. Implementation depth,
- 40 such as stakeholder consultations and case studies, will depend on available resources. There is
- 41 strong support from governance bodies, and the successful launch of case studies during London
- 42 Climate Action Week is a positive sign of the project's relevance and momentum.
- The following are key points from the discussion:
 - The GSSB questioned the reference to a 'standard' and whether the exposure draft refers to
 the guidance or the standard. While the intention is to integrate the guidance into GRI 3:
 Material Topics 2021, it could also be exposed separately depending on the project's direction
 and interlinkages.
 - The project aims to connect GRI's impact perspective with financial risk and opportunity assessments, bridging both reporting and risk management perspectives.
 - There is a call for ongoing involvement from GSSB members beyond governance stages, potentially through a working group or sponsorship role.
 - The project proposal was unanimously approved, with acknowledgment of the need to secure funding and resources for full implementation.
